1. Introduction of M&A Activities

&A activities, which is abbreviated by two English words including Mergers and Acquisitions, is a general term used to describe the consolidation of companies or assets through various types of financial transactions, including mergers, acquisitions, consolidations, tender offers, purchase of assets, and management buy-out (MBO), etc. in order to achieve their business and commercial aim.



Currently, M&A is an outstanding method in many global investment methods. M&A is a business strategy for the growth and development of enterprises. With economic momentum, the wave of M&A has been formed and developed for a long time over the world. For Vietnam, although M&A activities are extremely popular, many Vietnamese businesses are still not really interested and comprehensible. Many M&A deals are still going on, but the parties of the transaction still do not understand the essential stages for an M&A transaction. Therefore, after completing an M&A transaction, one of the parties often faces unforeseen legal and financial risks as well as unexpected losses.

2. The process of conducting a M&A transaction

Developing a strategy, clearly defining the potential Target Company.

2.

Evaluating these potential Target Company.

3.

Designing a strategy for merging, acquiring a part or all capital of the potential Target Company.

4.

Analyzing and valuing the potential Target Company.

Making a decision on mergering/non-mergering decision or purchasing / non-purchasing capital in the potential Target Company.

7.

stage Starting the the legal conducting financial appraisal, appraisal of the potential Target Company and the reassess original strategy.

6.

Signing a Confidential Agreement and a Memorandum about merging, acquiring a partial / full capital of the potential Target Company.

5.

Sending a proposal to the owner / shareholder / capital contributor of the potential Target Company and conduct negotiations.

Signing a merger / acquisition contract of part / all of the potential target company capital in case of a decision on capital acquisition / merger.

10.

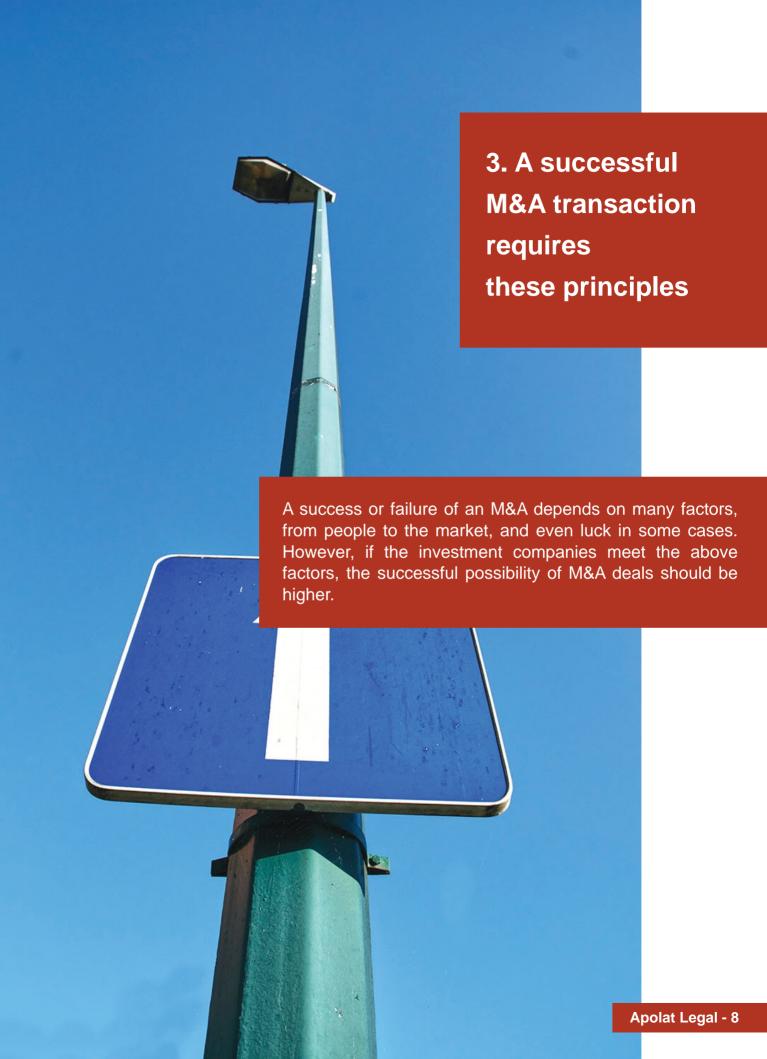
Fulfilling financial obligations.

Research on the Target Company

Understanding clearly the Target Company, especially the fields of business, customers, operating structure, culture and orientation of the Target Company; simultaneously, the investment enterprises must also skillfully capture and maintain the cultural values of the company after M&A.

Focus on the important aims

The value of a business is not only in tangible assets such as machines, factories, capital ... but also in other intangible assets such as strategy, vision, staff, brand, and exclusive products. Intangible value is also one of the factors affecting the value of M&A transaction.

3

Analyze and evaluate risks

The level of success after M&A transaction substantially on a clear plan and strategy with anticipated risk forecasts by Investors. Acquirers need to be careful with bad debts that are not recorded on the accounts, assets recorded in books but actually damaged or money arises not from the business of the Company ... In addition, the risk of lacking personnel also need to be considered because in many deals, key staff leave after mergers / capital purchases, leading to a shortage of personnel in the Company.

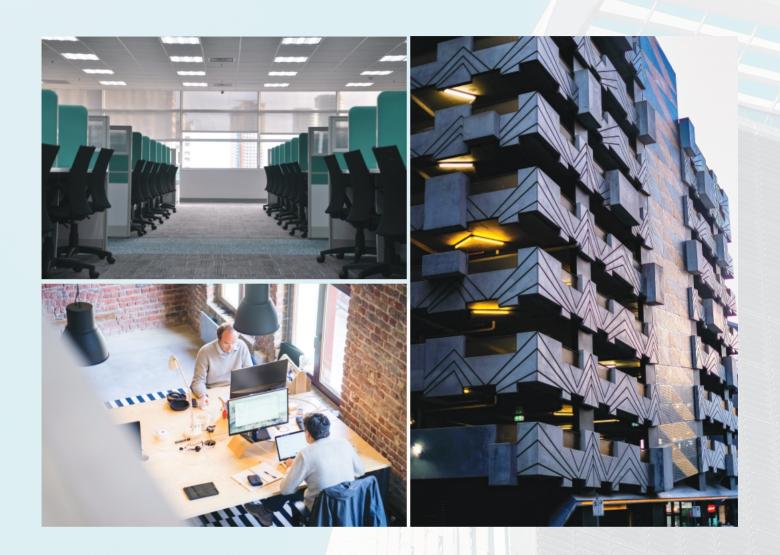
Use consulting advice in specific steps

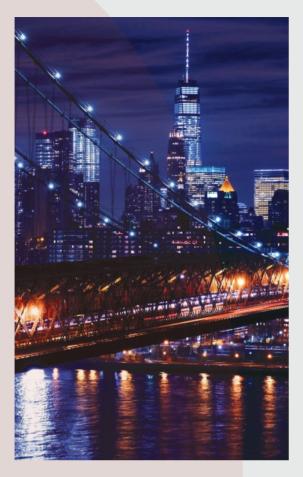
Be consistent in decision making and fulfillment of commitments and agreements
